



Offline Registration

It is a traditional method of registering the agreement

Customers have to come as per the SRO availability

Customer has to wait for longer hours until his turn comes for execution

Offline Registration is time consuming activity for the customer

The documents are typed on a hardcopy and thus, chance of errors are high

Online Registration

It is a modern way through digitization for registering the agreement

Customer is given a specific time for his registration

Customer completes his execution in less than half an hour within his allotted time slot



The Registration application facilitates the citizens for completing the pre-registration and registration activities






BENEFITS OF E-REGISTRATION
